Agenda

1. Welcome and Recap

- Andrew Bing, CAT facilitator, started the meeting and reviewed the agenda.
- Andrew provided a recap of the April 2025 CAT meeting, which focused on:
 - Reviewing progress on the Supplemental Environmental Impact Statement (SEIS)
 - Discussing MTA's role in station area planning
 - Continuing the Community Compact refresh process
- New CAT members and high school summer interns were welcomed.
 - Interns from Woodlawn, Patterson, and Edmondson High Schools introduced themselves to the CAT members.
 - The Red Line interns participated in a six-week paid internship focused on Red Line communications, planning, and design.

2. Greater Baltimore Committee President Mark Anthony Thomas featured as part of the "People of the Red Line Series"

• In this video, Mark Anthony Thomas described how the Red Line will be a transformative, generational investment for the Baltimore Region. The Red Line is anticipated to generate up to \$19 billion in economic return on

3. Project Director's Update

- Caitlin Tobin, Red Line Senior Project Director, welcomed Baltimore County Planning Director Steve Lafferty and City of Baltimore Deputy Mayor for Economic and Community Development Justin Williams.
- · Caitlin's opening remarks focused on:
 - Sharing the Red Line's funding outlook, with an emphasis on collaboration with economic development partners.
 - Announcing the Red Line Station Area Preservation and Investment Tour scheduled for Fall 2025
 - Inviting CAT members to identify key places and priorities in their communities for the tour.

4. MTA's Partners in Economic and Community Development

- MTA highlighted partnerships with Baltimore City and Baltimore County to align Red Line planning with broader revitalization efforts.
- Baltimore County Planning Director, Steve Lafferty, discussed initiatives including:
 - Security Square Redevelopment
 - Woodlawn Village Enhancements
 - Zoning Reforms
 - Attainable Housing
 - West Baltimore County Redevelopment Authority
- Baltimore City Deputy Mayor Justin Williams discussed the major development projects and policies that the city is advancing to support the Red Line corridor, including:
 - · Zoning Reforms
 - Vacant Housing Initiative
 - Harborplace/Downtown RISE
 - Edmondson Village/Uplands
 - · Perkins Somerset Oldtown

5. Planning for the Red Line Preservation and Enhancement Tour

- Yolanda Takesien provided an overview of the Red Line Preservation and Enhancement Tour. The tour will give CAT
 members a complete picture of the value and potential of the Red Line investment for the people and places being
 connected. CAT members were organized into station area clusters with interns and City/County representatives
 to:
 - Review access, transportation, and economic activity maps
 - Identify key destinations, development opportunities, and community priorities
 - Suggest tour stops for the September corridor tour
- Each breakout group was organized by cluster area, which included:
 - Access and transportation network maps
 - Jobs and economic activity data
 - Demographic and housing statistics
 - Community risk and development indicators
- Breakout group participants were encouraged to mark maps with:
 - 1. Purple circles for places of cultural, historical, or community value
 - 2. Green circles for areas of change or opportunity

Andrew concluded the meeting with a reminder of the CAT office hours for August 13.

- New pad sites at the Edmondson Shopping Center
- Meals-on-Wheels forthcoming, behind the Shopping Center
- Saint Bernadine's Church
- West Baltimore MARC Station
